O P I N I O <u>N</u>

This is **an** appeal pursuant to Section 20 of the Personal Income Tax Act of **1935** (Chapter 329, Statutes of 1935) from the action of the Franchise Tax Commissioner in denying **Appellan**¹ claim for a refund of tax alleged to have been overpaid by her for the taxable year ended December 31, 1936, in the amount of \$41.05.

The issue involved in this appeal is identical with the issue involved in the appeal, this day decided by us, of C. $^{\rm H}$. Wilcox. Upon the basis of our decision in that appeal, we must hold that the Commissioner acted improperly in denying the claim for a refund.

ORDER

Pursuant to the views expressed in the opinion of the Board on file in this proceeding, and good cause appearing therefor,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the action of Chas. J. McColgan, Franchise Tax Commissioner, in denying the claim of Helen Wilcox Corbett for a refund of personal income tax in the amount of \$41.05 for the taxable year ended December 31, 1936 be and the same is hereby reversed. The Commissioner is hereby directed to give credit to Helen Wilcox Corbett for said amount of \$41.05 paid by said Helen Wilcox Corbett for said year or to refund said amount to said Helen Wilcox Corbett and otherwise to proceed in conformity with this order.
