Issues: Whether respondent has proved appellants' fraud or intent to evade the Sales and Use Tax Law or authorized rules and regulations by clear and convincing evidence; whether adjustments to the measure of unreported taxable sales are warranted; whether respondent properly imposed the 40 percent penalty on Ava Beri Restaurants Group, Inc. (ABRG) for its failure to timely remit tax reimbursement collected from customers; if respondent properly imposed the 40 percent penalty on ABRG, whether the evidence establishes that ARGB's failure to timely remit the sales tax reimbursement collected from customers was due to reasonable cause or circumstances beyond the ABRG's control, and occurred notwithstanding ABRG's exercise of ordinary care and it's absence of willful neglect; and, whether relief of the finality penalty, which respondent imposed on ABRG, is warranted.
